ComfortStar USA warrants that the Portable Air Conditioning Product and Dehumidifiers conforms to the manufacturers specifications, and will be free of defects in material and workmanship. Should any defect occur, ComfortStar USA, will correct the defect, to the original owner, subject to the following conditions:

ComfortStar USA warrants this product for a period of one (1) year from the date of original installation by a licensed HVAC contractor to the original owner at the owner's premises. Installation date is verified by a copy of the original purchase receipt from your installing Contractor.

ComfortStar USA warrants this product in any Commercial Installation or Application for a period of ninety (90) days from the date of the original purchase by the original owner, and only if the product is installed on the original owners premises.

ComfortStar under the terms of the parts warranty, will provide a replacement part at no charge, freight collect. Parts used for replacement may be of like kind and quality to the original part. Parts replaced under warranty, will be warranted only for the remainder of the original warranty period.

This Limited Warranty does not include labor or any other costs incurred for service, repair, installation, removal, shipping or handling of replacement parts. Some or all costs of labor may be covered under a separate and independent warranty offered by the installing contractor.

This Limited Warranty also does not cover the following items:

- System Installation and items provided as additional "add-on" products during installation
- Removal of protective material or disposal of packaging
- Usage outside of the design specifications and limitations outlined by the manufacturer
- Any service required to correct improper installation, improper sizing, or to correct improper supply voltage at the installation site.
- Damage from improper installation, modification, or use in conjunction with other products
- Any loss, damage, failure, or personal injury due to accident, neglect, or abuse by the consumer, including improper operation, maintenance, storage, alteration or failure to follow normal installation and maintenance procedures outlined in the installation and instruction manuals.
- Damages caused by force of nature or other factors beyond reasonable control, such as power surge damage caused by lightning, power fluctuations, or interruptions of electrical power and/or flood.
- Any unit purchased by an unauthorized dealer, or any unauthorized online retail operation.
